This award is for an outstanding new arts, cultural or creative work by an organisation, presented for the first time in South Australia between 1 July 2025 - 30 June 2026.

Nominated works and events must have premiered in South Australia between 1 July 2025 and 30 June 2026.

Nominees must reside or be based in South Australia OR have been a resident or based in South Australia during a period of major professional achievement or development.

Nominations can be made in up to two award categories for a single event or project. Each nomination should address the specific category in which it is being considered.

This award is open to work that premiered between 1 July 2025 - 30 June 2026 by:

- arts, cultural and creative industries
- community organisations
- local and state government
- not-for-profit sector

- Stevie Gadlabarti Goldsmith Memorial Award
- Geoff Crowhurst Memorial Award
- Frank Ford Memorial Award.

You can nominate the same work in up to two award categories.

Each nomination must explain how the work meets the criteria for that category.

If you are nominating an individual, you must include written confirmation that they agree to being nominated.

By submitting a nomination, you give CreateSA permission to use your application materials to promote the Ruby Awards and South Australia's arts, culture and creative industries. This may include advertising, publicity and displays.

All nominees must be available to participate in promotional activities if requested.

This may include media interviews, photography and filming.

Nominees must be available to attend the awards presentation event on Friday 13 November 2026.
